 - Joint Commissioning Integrated Board, Be Birmingham, Children's Trust, Directors of Public Health , Finance and Commissioning.
 - City Council Cabinet

Recent highlights and drivers

- **Funding settlements for 2011/12 and medium term. Increasing alignment between health and care.**
- **New policies – two of three White Papers, and many consultation papers**
- **Faster pace, complete system change**
 - BHWP Executive (ceased for time being, now using Cluster governance)
 - PCT reconfiguration, Transforming Community Services, Local Government Transformation
- **GP and Health and Wellbeing Board Pathfinders**
- **NHS QIPP (Quality, Innovation, Productivity, Prevention) System Plans**

2010/11 Priorities

Whole health and care system change

- Cluster: single executive teams by June 2011
- Not just NHS, commissioning and provision
- Acute and community services
- Inter-dependencies and risks
- Health and Wellbeing Board

Community-based budgets

- Joining up transformation programmes
- Optimal care – whole systems
 - e.g. falls, dementia, stroke
- City-wide Prevention Framework (Public health driven)
- Families with complex needs pilots

2010/11 Priorities

Efficiencies

- Local Government
 - eg. City Council £330m real reduction next 3 years
- £107m per annum for Adults and Communities alone
 - new budget offer out for consultation
- £300m local NHS QIPP savings next 3 years
- Working closely together on linkages and risks

2010/11 Priorities

Health Inequality Actions

- **Life Expectancy:** Raising the bar in primary care, looking at both length and more importantly quality of life
- **Infant Mortality:** Focus on maternity care and smoking in pregnancy and addressing apparent significant cultural and geographical imbalances
- **Tobacco Control:** Smoking in pregnancy and routine and manual workers. City-wide strategy
- **Obesity:** ‘Be active’ programme, obesity strategy, achievement of LAA child obesity target and nutrition work and obesogenic environments
- **Employment and Health:** ‘Fit For Work’ national pilot, incapacity benefits and other changes. Supporting GPs and local employers

2010/11 Priorities

Knowledge Management

- JSNA work programmes (key to improving commissioning and decommissioning)
- Real evidence from local people
- Bring information systems and evidence together
- Public Health Information Team portal for GPs etc.

Local Area Agreement/Other Joint Targets

- Locally set targets: even more important with Audit Commission going
- Delayed transfers of care, end of life care, self directed support

2010/11 Priorities

Children's Issues

- Maternity care and Infant mortality
- Supporting OFSTED/CQC improvement action plan

Personal Health Budgets (leading edge DH pilot)

- More patients signed up than anywhere else
- COPD, Diabetes, Mental Health
- Joining up with social care Individual Budgets?

Carers

- Joining up across health and care
- Scaling up local excellent practice, advice and support
